<p>Violation #43. In-use utensils: properly stored -Scoop was stored outside of brown rice on container with food debris. Corrected action: Scoop was removed to be cleaned and sanitized. Corrected on site (COS)</p> <p>CODE REFERENCE: 64E-11.003(4). The establishment shall use an approved method for the storage of in-use utensils during pauses in food preparation or dispensing.</p>
<p>Violation #47. Food &amp; non-food contact surfaces -Clean and sanitize brown sugar and brown rice container with food debris on the bottom. Corrected action: Containers were cleaned and sanitized. Corrected on site (COS)</p> <p>CODE REFERENCE: 64E-11.003(4). Equipment and utensils must be properly designed, constructed, and in good repair.</p>
