-Clean and sanitize inside of ice machine build up was observed. Corrected action: Ice machine was cleaned and sanitized. Corrected on site (COS)
CODE REFERENCE: 64E-11.003(2). Food shall only contact surfaces that are clean and sanitized.

Violation #56. Ventilation & lighting

-Replace light bulb and provide missing light fixture in walk-in freezer.

CODE REFERENCE: 64E-11.003(6)(a). Adequate exhaust ventilation hood systems in food prep and warewashing areas shall be provided and designed. 50 foot candles shall be at surfaces where employees work with food and 20 foot candles shall be at surfaces where food is provided to consumers.
